ARTICLE 1: MAINTAIN A THREE-MEMBER SELECT BOARD

Majority Vote

To see if the Town will vote to rescind the vote taken at the May 12, 2025 Annual Town Meeting under Article 34, which vote authorized the Select Board to petition the General Court for a special act to increase the membership of the Select Board from 3 members to 5 members; and, further, to direct the Select Board and the Town Clerk to send a certified copy of the Special Town Meeting warrant and the vote taken hereunder to the Clerks of the Massachusetts House and Senate for distribution to the Joint Committee on Municipalities and Regional Government and to the Town's State Representative and State Senator, and, in turn, to request that the General Court take no further action on House Bill 4245 (or any similar bill for the Town of Mattapoisett), and withdraw the bill from any and all further consideration; or take any action relative thereto.
