ARTICLE 38: - OLD COLONY REGIONAL VOCATIONAL HIGH TECHNICAL HIGH SCHOOL DISTRICT - PROPOSED AMENDMENT TO SECTION XIII OF THE REGIONAL AGREEMENT

To see if the Town will vote to replace Section XIII of the Regional Agreement of the Old Colony Regional Vocational Technical High School District with the following as recommended by the Old Colony Regional Technical High School District Committee with the following:

INCURRING OF DEBT – Within seven (7) days after the date on which the Committee authorized the incurring of debt, other than temporary debt in anticipation of revenue to be received from member towns, the said Committee shall cause written notice of the date of said authorization, the sum authorized, and the general purpose or purposes for authorizing such debt, to be given to the Board of Selectmen of each member town. The notice for which provision in herein made shall be deemed to have been duly give to the Board of Selectmen of a member town if delivered to the Chairman of said Board or if mailed by registered or certified mail within the time specified, postage prepaid and addressed to the Chairman of said Board at the Selectman's Office or at his last known permanent address in such town. Within sixty (60) days after the date on which the Committee authorized the incurring of said debt, each member town shall hold a town meeting for the purpose of expressing approval or disapproval of the amount of said debt and if at such meeting a majority of the voters present and voting thereon express disapproval of the amount authorized by the committee, the said debt shall not be incurred and the Committee shall thereupon prepare another proposal which may be the same as any prior proposal and an authorization to incur debt therefor.

ARTICLE 39: ZONING BYLAW AMENDMENT

To see if the Town will vote to amend the Town of Mattapoisett Zoning Bylaws by the following:

Section 8.2.1 shall read: "The Floodplain District is herein established as an Overlay District. The District includes all special flood hazard areas within the Town of Mattapoisett designated as Zone A, AE, or VE on the Plymouth County Flood Insurance Rate Map (FIRM) issued by the Federal Emergency Management Agency (FEMA) for the administration of the National Flood Insurance Program. The map panels of the Plymouth County FIRM that are wholly or partially within the Town of Mattapoisett are panel numbers 25023C0553J, 25023C0554J, 25023C0558J, 25023C0564J, 25023C0564J, 25023C0566J, 25023C0567J, 25023C0568J, 25023C0569J, 25023C0627J, and 25023C0650J with an Effective Date of July 17, 2012. The exact boundaries of the District may be defined by the 100-year base flood elevations shown on the FIRM Maps and further defined by the Plymouth County Flood Insurance Study (FIS) Report with an Effective Date of July 17, 2012. The FIRM and FIS Report are incorporated herein by reference and are on file with the Town Clerk, Planning Board, Building Official, Conservation Commission and the Board of Selectmen's Office.

Section 8.2.2. shall read: "The Floodplain District is established as an overlay district to all other zoning districts. All development in these districts, including structural and non-structural activities, whether permitted by right or by special permit must be in compliance with Chapter 131, Section 40 of the Massachusetts General Laws and with the following:

- Sections of the Massachusetts State Building Code (780 CMR) which address floodplain and coastal high hazard areas;
- Wetlands Protection Regulations, Department of Environmental Protection (DEP) (currently 310 CMR 10.00);
- Inland Wetlands Restriction, DEP (currently 310 CMR 13.00);
- Coastal Wetlands Restriction, DEP (currently 310 CMR 12.00);
- Minimum Requirements for the Subsurface Disposal of Sanitary Sewage, DEP (currently 310 CMR 15, Title 5);

Any variances from the provisions and requirements of the above referenced state regulations may only be granted in accordance with the required variance procedures of these state regulations.

In Section 8.2.8, remove reference to V1-V30 and V

Add Section 8.2.8.2: Man-made alteration of sand dunes within Zones VE which would increase potential flood damage are prohibited.

Section 8.3 and 8.4: Mattapoisett only has zones VE, AE, and A, therefore references to other zones are deleted.

Add a Section 8.5 "Use Regulations"

Add Subsection 8.5.1: In Zones A and AE, along watercourses that have not had a regulatory floodway designated, the best available Federal, State, Local, or other floodway data shall be used to prohibit encroachments in floodways which would result in any increase in flood levels within the community during the occurrence of the base flood discharge.

Add Subsection 8.5.2: Base flood elevation data is required for subdivision proposals or other developments greater than 50 lots or 5 acres, whichever is the lesser, within unnumbered A zones.

Add Subsection 8.5.3: In a riverine situation, Zoning Enforcement Officer shall notify the following of any alteration or relocation of a watercourse:

- Adjacent Communities
